



# U.S.A. MINIMUM ADVERTISED PRICE POLICY CORRAL BOOT COMPANY, LLC

---

## 1. INTRODUCTION

As a result of its focus on beautiful and innovative design, quality materials, detailed workmanship and diverse product lines, Corral Boot Company, LLC ("Corral") has become a world leader in the western wear market place. Corral's customers include people from all walks of life who are committed to style and quality. These customers are loyal to the Corral brand as it exemplifies what they value in western apparel.

Corral has determined that advertising select Corral products at prices below certain levels established by Corral undermines Corral's trade reputation, image, and marketing strategy, and also makes it less likely that our retail partners ("Retailers") will carry Corral products and/or earn sufficient profits. To ensure the value of the image of Corral to their customers and to protect our Retailers, Corral has unilaterally established this Minimum Advertised Price ("MAP") Policy.

## 2. POLICY STATEMENT

Corral, in its sole discretion, reserves the right to discontinue doing business with any Retailer that advertises any product(s) covered by this MAP Policy at a price lower than the MAP. By failing to adhere to Corral's established MAP, Retailers will have the dramatic effect of diminishing and/or detracting from the perceived value of all Corral products. Corral will unilaterally enforce this policy, strictly and uniformly, with respect to all Retailers.

## 3. GENERAL GUIDELINES

A. This MAP Policy applies to all Corral products which the Retailer is authorized to sell pursuant to a distributorship agreement or other similar agreement with Corral (the "Corral Products").

B. Corral recognizes that Retailers are free to make their own decisions to advertise and sell any Corral Product at any price they choose, without consulting or advising Corral. Similarly, Corral will exercise its right to make its own decisions regarding entering into distributorship agreements, supplemental marketing materials, point-of-purchase displays, product allocation, new product availability, or future promotional, joint marketing, or sponsorship programs.

C. The MAP Policy applies to advertised prices, not the price at which Corral Products are actually sold or offered for sale to an individual in-store or over the telephone.

D. Corral believes in maintaining a well-regulated and fair marketplace for all its authorized Retailers.

## 4. ADVERTISING GUIDELINES

A. Corral Products may not be advertised at a price less than the "Minimum Advertised Price" or "MAP." Retailers that advertise Corral Products at a price less than the MAP may face discontinuance of their business relationship with Corral.

B. The current MAP for Corral Products ("MAP Price List") will be emailed to each Retailer and will be posted by Corral at [www.corralboots.com/map.price.list.pdf](http://www.corralboots.com/map.price.list.pdf). Alternatively, the MAP Price List may be obtained by contacting Corral directly at MAP@corralboots.com. Each Retailer shall be responsible for regularly reviewing the posted MAP Price List and assuring that it is aware of the current MAP for Corral Products.

C. The MAP Policy applies to all advertisements of Corral Products. "Advertisement" shall include any price of Corral Products accessible, provided to or viewable by consumer(s) whether provided digitally, via the internet, through traditional media such as print, flyers, posters, coupons, mailers, inserts, newspapers, magazines, catalogs, signage, radio or television, as well as internet sites, social media sites, apps, or any other electronic media.

D. The MAP Policy does not apply to point of sale signs, hangtags, barcodes, and other in-store markings on products, nor will it apply to the displaying of a price during the "checkout" stage for online purchases.

E. Website features such as "click for price," automated "bounce-back" pricing e-mails, pre-formatted e-mail responses, forms, automatic price display for any items prior to being placed in a customer's shopping cart and other similar features are considered to be communications initiated by the Retailer (rather than by the customer) and thereby constitute "advertising" under this MAP Policy.

F. It shall not be a violation of this MAP Policy to advertise that a customer may "call for price" or "email for price," or to use similar language, specifically with respect to Corral Products, so long as no price is listed.

G. This MAP Policy also applies to any activity which Corral determines, in its sole discretion, is designed or intended to circumvent the intent of this MAP Policy, such as solicitations for "group purchases" and the like.

H. It shall not be a violation of this MAP Policy to advertise in general that the Retailer has "the lowest prices" or will match or beat its competitors' prices, or to use similar phrases; so long as the Retailer does not include any advertised price below MAP and otherwise complies with this MAP Policy.

I. From time to time, Corral may permit Retailers to advertise Corral Products at prices lower than the MAP.

In such events, Corral reserves the right to modify or suspend the MAP with respect to the affected products for a specified period of time by providing advance notice to all Retailers of such changes.

J. Additionally, Retailers may advertise Corral Products at prices lower than the MAP if the Retailer chooses to participate in a "Corral Advertised Price Promotion" ("CAPP"). Retailers may participate in a CAPP no more than four times a year. Each CAPP shall continue for no more than five consecutive days. CAPPs may not be scheduled consecutively. During the CAPP Retailers may advertise Corral Products at a price no lower than the CAPP Price List which will be emailed from time to time to each Retailer and will be posted by Corral at [www.corralboots.com/capp.price.list.pdf](http://www.corralboots.com/capp.price.list.pdf). Alternatively, the CAPP Price List may be obtained by contacting Corral directly at [CAPP@corralboots.com](mailto:CAPP@corralboots.com). The CAPP Price List will only apply to products designated in the list. The MAP Price List will apply to all other products. All CAPPs must be scheduled in advance by calendar year with prior written notice and approval from Corral. Retailer participation in a CAPP is voluntary.

K. From time to time, Corral may offer a direct manufacturer's rebate to customers. In such events, it shall not be a violation of this MAP Policy to advertise the availability of the manufacturer's rebate, provided that:

- i. the advertisement includes a MAP-compliant price, the rebate amount, and the net price after manufacturer's rebate in the same type size and style;
- ii. an asterisk is placed next to the net price after manufacturer's rebate; and
- iii. "after manufacturer's rebate" appears in the same area of the advertisement as the advertised product.

L. Free shipping or sales tax rebates offered in combination with a product that is otherwise advertised in accordance with this MAP Policy will not be considered a violation of this MAP Policy. Loyalty programs offering a credit or discount to be applied to future purchases at the Retailer with the purchase of a Corral Product will not be considered a violation of this MAP Policy.

## 5. POLICY ENFORCEMENT

A. Corral reserves the right to cancel any pending orders, restrict future orders, or suspend Retailer's account if Corral reasonably believes:

- i. a dealer has violated the provisions of this policy; or
- ii. a dealer intends to violate this policy.

B. Corral is solely responsible for determining whether a violation of the MAP Policy has occurred, as well as determining appropriate sanctions.

C. Waivers to this MAP Policy may be granted in Corral's sole discretion. Any waiver must be in writing and signed by Corral corporate management. Corral sales, marketing, or other personnel are not authorized to modify or grant exceptions to the MAP Policy. In the event that Corral authorizes a waiver to the MAP Policy, Retailers must strictly adhere to the terms of the waiver letter. Deviation from the terms of a waiver letter is a violation of the MAP Policy.

D. Corral monitors the advertised prices of Retailers, either directly or via the use of third-party agencies or tools. Retailers are expected to provide reasonable cooperation in any Corral investigations regarding possible MAP Policy violations. Hindering, obstructing, delaying, or otherwise failing to cooperate with a Corral MAP Policy investigation is a violation of this MAP Policy.

E. The MAP Policy will be enforced by Corral in its sole discretion and without notice. Retailers have no right to enforce the MAP Policy. Violations of this policy may result in any of the aforementioned sanctions up to and including termination of our business relationship, as well as any available remedies at law.


